State-of-the-art Doing Business 2019

- The revisions of laws and regulations are ongoing as follows:
- Enacting the Act Amending the Civil Procedure Code (No. 30), B.E. 2560 (2017),
- Proposing draft Ministerial Decree on Setting Rules, Measures and Conditions of the Public Auction B.E.,
- Proposing draft Ministerial Decree on Qualification, Setting Rules, Measures and Conditions of Authorized Person to Perform in Substitution of Enforcement Officer B.E. ...,
- Proposing draft Enforcement Officer Act B.E. ...,
- Proposing draft Ministerial Decree on Setting Rules, Measures and Conditions of the Public Auction via Electronic Means B.E.

e-Service Action Plan in 2019

- Photocopy service is initiated to serve copies of judgements among the Courts of Justice.
- e-Database is implemented as the first phase.
- ✓ E-Filling is enhanced to provide synergetic ways of organising submitting, sending and receiving Pleadings.
- e-Hearing recording system is enhanced during judicial review of the inquest.
- Electronic Courtroom is initially established as a pilot project.
- Case Information Online Service (CIOS) is created to provide database of Legal Execution Department and Court of Justice (MOU was also signed between Legal Execution Department and Court of Justice on 26 December 2017).
- e-Queuing system is initiated to schedule a time slot for enforcement process.
- e-Offering Auction Project System is strengthened.
- Electronic attachment systems are developed.
- Status of the cases can be tracked.
- e-Offering is strengthened.
- e-Queuing system is initiated to enforcement procedure.

Previous Action of Doing Business 2018

- e-Filing and electronic system in Legal Execution Department were implemented to foster public service provision.
- e-Registration was established.






Resolving Insolvency



State-of-the-art Doing Business 2019

- The Bankruptcy Act (No. ..) B.E. regarding bankruptcy and business reorganization cases was approved by the National Legislative Assembly resolutions in the Second and Third readings on 25 December 2017.
- The Bankruptcy Act (No. ..) B.E. regarding international insolvency in ongoing amendment.
- The Official Receiver is allowed to advertise Court's order or decision, or the Receiver's announcement or order through www.led.go.th.
- Information is transferred to Royal Thai Government Gazette via electronic system.
- Effort has been devoted to transform operator into 'regulator' (private official receiver).

Ongoing e-Service

- Mobile application was established to check the bankruptcy and business reorganization status (this service was available from November 2017)
- Database linkage system is developed to link 14 public sector registrars' data (in testing system).
- Database linkage system is developed between the Legal Execution Department (LED) and banks, and between the LED and the Central Bankruptcy Court (in consultation).
- Asset-Tracking System is initiated (this service will be available in 2018).
- E-Insolvency Case Management is strengthened (progress being made by adding data).

Previous Action of Doing Business 2018

The voting procedures for the business reorganisation plan was changed to easily address the challenges in resolving insolvency.
